Haulage Booking Terms and Conditions

1. Introduction

These Terms and Conditions ("Terms") apply to all haulage services provided to Landguard Point Ltd. ("the Company"). By engaging in haulage services to the Company, all hauliers ("the Haulier") agree to adhere to the following Terms.

2. Insurance Requirements

- **Goods in Transit Insurance:** All Hauliers must have valid and adequate Goods in Transit Insurance to cover the full value of the goods being transported. Proof of insurance must be provided to the Company upon request.

3. Load Security

- **Secure Strapping:** All goods must be securely strapped down by the Haulier to ensure safe transit. The Haulier is responsible for providing the necessary equipment and materials to secure the load.

4. Driver Responsibilities

- **Load Responsibility:** The driver is wholly responsible for the load during transit. This includes ensuring the load is properly secured, safe handling of the goods, and compliance with all applicable laws and regulations.
- **Health and Safety Compliance:** The driver must adhere to all health and safety rules and regulations at both the loading point and the delivery point. This includes following any site-specific guidelines provided by the Company or the receiving party.

5. Communication of Delays

- **Anticipated Delays:** Any anticipated delays in delivery must be communicated to the Company immediately. Landguard Point Ltd will not accept any demurrage charges or changes to the booked confirmed job rate unless prior agreement has been made and confirmed in writing.

8. Vehicle Specifications

Haulage booked must comply with the following vehicle specifications:

- Trucks required as standard 45ft Flat or Full Height Tautliner **No Euro Liner accepted**
- Full weight 44 Ton
- 3x3 axle configuration
